

**Conversion Charts for Transfer Students’ Pre-Transfer Test Scores for Specified Assessments
to Meet High School Graduation Requirements at a New Public or Chartered Nonpublic School**

Effective April 6, 2023, the Department has adopted standards that allow a transfer student who, prior to transferring, “took an assessment described in division (B)(1) or (2) of section 3301.0712 or section 3313.619 of the Revised Code to apply the score from that assessment towards graduation requirements at the student's new public or chartered nonpublic school.”¹

A transfer student may substitute their score from a nationally standardized assessment (ACT or SAT), end-of-course (EOC) exam or other permitted alternative assessment (IOWA Tests or Terra Nova Test) taken prior to their transfer toward graduation requirements at their new school if the score meets the remediation-free or competency cutoffs in Table 1 or Table 2. This flexibility applies to transfer students who entered high school on or after July 1, 2019.

Table 1 – Remediation-free scores for the ACT and SAT that may be used by transfer students as proxies for Ohio’s State Test end-of-course exams under Revised Code section 3301.0712(B)(1) or (2)

The nationally standardized assessment options under division (B)(1)(a) of section 3301.0712 of the Revised Code are the ACT and the SAT. Eligibility is determined by the substitution of tests and attaining the “remediation-free” scores in each of the three subject areas, two in English language arts and one in mathematics, as described in Table 1.

Table 2 – Scores for alternate assessments that may be used by transfer students as proxies for Ohio’s State Test end-of-course exams under Revised Code section 3313.619

The IOWA Tests and the Terra Nova Tests are approved by the Department for use under section 3313.619 of the Revised Code. (To receive Department approval, test vendors have provided linking studies comparing performances from Ohio's tests and their tests by the same students in the same subject to establish the comparability between the tests.) Eligibility is determined by the substitution of tests and attaining the cut scores as described in Table 2.
